**Limited Companies** – A limited company is a legal business entity that enables shareholders to limit their liability to the sum of their investment structure. It provides the right to participate in the profits without any personal liability and is not available for public sale on a stock exchange.

**Limited Liability Partnership** – A limited liability partnership is a separate legal entity from its members (partners), who are only liable for the amount of money they invest, plus any personal guarantees. The partnership is incorporated at Companies House.

**Public Limited Company** – Public Limited Company (Plc) is where they can offer their shares publicly on a stock exchange.

**UK Holding Companies** – Used to minimize the tax charged on international income flows.

**UK Special Purpose Vehicles used to transfer the corporate's balance sheet assets** into a bankruptcy-remote limited recourse structure.

### LEGAL FRAMEWORK

The UK has a common-law jurisdiction. It is known for having a stable democratic government and a respected system of law that countries have adopted across the globe. From a tax perspective, it can also be an attractive base for wealthy individuals and families taking advantage of the special tax treatment available to those who are not domiciled in the UK.

UK common-law and, in particular, relating to UK Trusts, was developed in the 12th century to ensure assets were protected and passed on to future generations. The same principles are used in Trusts globally today.
