- Assets are not subject to income, estate, inheritance, gift, or transfer taxes

The trust enjoys an unlimited duration and the prevention of forced heirship claims of non-US jurisdictions.

- An investment committee, advisor, or trustee:
 - Responsible for selecting outside investment advisors and managers to direct the trust's investments
- A distribution committee, advisor, or trustee:
 - Responsible for determining when and how distributions should be made
- An administrative trustee:
 - Receives contributions, handles day-to-day responsibilities, and is directed by the committees/ trustees to make investments and distributions and serve as any of the other Committees.
